

WAIVER & RELEASE OF LIABILITY FOR MINORS AND PARENTAL INDEMNITY AGREEMENT

Minor Member or Participant(s) Name(s) (Please Print) _____ In consideration for permission to participate in any activity at any facility or club, including the use of any child monitoring services and facilities offered at the club and all facilities, today and on any future dates, I, for myself, and on behalf of the minor child identified above, our heirs, personal representatives and/or assigns, do hereby release, waive, discharge, and covenant not to sue the club nor the facility, its directors, officers, owners, employees, independent contractors or agents (collectively referred to herein as the "Club" or facility), from liability for any and any claims for personal injury, illness, virus exposure, death, property damage, or any other claim, including but not limited to claims arising out of the negligence of the Club or the facility, its employees or its agents. This waiver and release of liability applies to any Club activities or facilities, without limitation, regardless of whether participation requires the Participant to leave any venues of Knoxville Badminton Club or premises. It is expressly agreed that participation in any Club activities, including but not limited to the use of the Club premises, without limitation and whether engaging in exercise or physical activities or not, should be undertaken by the minor member or participant at his/her sole risk, and the Club nor the facility be liable for any injuries, illnesses, virus exposures or any damages to any minor member or participant, or the property of any minor member or participant, or be subject to any claim, demand, damages or causes of action arising out of the use of, or occurring on, the Club's premises regardless of whether it was caused by the negligence of the Club or the facility. This waiver and release is intended to be as broadly interpreted as allowed under Tennessee law. The Parent/Guardian executing this waiver and release of liability hereby agrees to hold the Club and facility, its directors, officers, owners, employees, independent contractors and/or agents harmless from any claims which may be made by or on behalf of any minor member or participant listed on this agreement or any of their guests and to indemnify the Club nor the facility from any such claims to the fullest extent allowed under Tennessee law. This express indemnification provision specifically includes reimbursement for any and any attorneys' fees and litigation costs incurred by any Knoxville Badminton Club or facility on its behalf as a result of any such claim. The Parent/Guardian also expressly acknowledges that by signing below he or she is relinquishing any rights he or she may have to sue any the Club or the facility for injuries arising out of the use of any Venues of Knoxville Badminton Club/Annoor Academy or its services that arise during the minor's use of or presence upon any Knoxville Badminton Club or the premises. The Parent/Guardian also acknowledges that he or she is relinquishing, on behalf of the minor children participating at the Club or using the facilities, any rights the child may have to sue the Club for injuries arising out of the use of the Club facilities or its services regardless of whether the injuries were caused by the negligence of the Club or facility or its employees or agents.
